5. ENTRY AND ADMINISTRATION

14.12: ENTRY AND ADMINISTRATION

Each Federation shall declare, through EMS, not later than 75 days before the scheduled start of the first event of the World Championships:

- The names of the members of its team
- The names of the competitors entered as "Individuals"
- The names of the competitors entered as Wild Cards
- The names of the Official reserves.

For each competitor registered, the events that they will compete in together with the ramp height for Jump need to be entered.

An entry is considered complete when the Skier's name is registered in EMS and the full Entry Fee Payment has been received.

All payments need to be made by Credit Card/PayPal through EMS. For the Official Reserves, no payment is due at this time.

Any skier entered as a Wild Card or Individual is also to be considered to be a TEAM reserve.

An entered skier may be replaced by a different one without penalty, provided that they have already been entered as a Reserve skier, wild card or individual.

The 75 days deadline does not include those skiers who may additionally qualify as individuals through the Weekly or the Pro Ranking List (If applicable). For those skiers the following deadlines apply:

The deadline to enter skiers who qualify under the Weekly Ranking List is 30 days before the Championships.

The deadline to enter skiers who qualify under the Pro Tour Ranking List is 15 days before the Championships.

a) Fines for Late Registration.

Any Federation not meeting the registration deadlines will not be allowed to compete until their Federation pays a fine to the IWWF Representative at the Championships. The fines are as follows:

- * US\$25 per skier if the registration is made between 74 and 60 days before the scheduled start of the first event of the World Championships
- * US\$50 per skier if the registration is made between 59 and 45 days before the scheduled start of the first event of the World Championships
- * **US\$75** per skier if the registration is made between 44 to 30 days before the scheduled start of the first event of the World Championships
- * **US\$100** per skier if the registration is made between 29 to 15 days before the scheduled start of the first event of the World Championships
- * Double the Entry Fee per skier if the registration is made between 14 days until 12:00 (competition local time), 2 days before the scheduled start of the first event of the World Championships

Example: scheduled start of the first event of the World Championships is July 31 deadline to register skier is noon 12:00 UTC of July 29.

Two days before the start of the first event the entry lists shall be closed at noon 12:00 (competition local time) and thereafter the order of competitors entered and paid will be finalised and posted.



























The Scorer in consultation with the Chief Judge should post Preliminary Running Orders 7 days preceding the start of events with the orders clearly marked as "Preliminary and subject to change". No change in this order is allowed after noon (competition local time) of the two days preceding the start of events except that a team representative may without penalty:

- 1) Withdraw a skier from the competition.
- 2) Replace an injured skier with a qualified official reserve from the same team with the authority of the Chief Judge and before the start of the first event, that is, before the first skier taking part in the first event has started.
- 3) The substitute skier shall start first in the series in which he is qualified unless the draw has not yet been completed.

b) Team or individual athletes not showing up:

In the event a team or individual athletes (for whom their Federation has submitted a competition entry), fail to show up for a competition, their entry fee shall still be payable in full, unless a valid written excuse is received by 12 noon of two days before the start of the competition.

A valid excuse may include a sickness certificate or a certificated injury and should be considered and agreed as valid by the IWWF Representative at the Championships.

All fines have to be paid on-site to the IWWF Representative at the Championships. No skiers will be allowed to start if any due fine is not paid.

If the "valid excuse" is accepted, the money will be refunded by the Organiser to the relative Federation, within 30 days after the end of the competition.

ENTRY FEE

The Entry Fee for the 2025 IWWF World Waterski Championships is € 350,00 per competitor regardless of discipline. The Entry Fee includes the final night banquet but does not included lunches on site.

ENTRY FEE PAYMENTS

Payments of the Entry Fees must be made at the time of athlete registration on the EMS website. Once payment is made, please mail your proof of payment to: 2025worlds.secretariat2@gmail.com Remitting parties are responsible for ALL bank charges at both ends. Where bank charges have been deducted, Federations/Skiers will be required to make good any shortfall at registration.

6. OFFICIAL FAMILIARISATION

14.07: SITE FAMILIARISATION

The last two or three days immediately before the Championships will be reserved and used for Official Familiarisation. This will be organised so that each competitor who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge based on the principle that every skier shall receive an equal opportunity for familiarisation.

Slalom skiers will receive - 4 passes or 6 minutes whichever is less Tricks skiers will receive - 2 passes or 5 minutes whichever is less Jump skiers will receive - 3 passes or 6 minutes whichever is less

60 days before the Championships each entered competitor will be allocated Official Familiarisation time as specified above. 45 days before the scheduled start of the event, the Organiser (in consultation with the Chief Judge, whose decision shall be final) shall announce the official familiarisation schedule (including the allowed time).

If a Federation does not want to take part in the Official Familiarisation, it must notify the Organisers and the Chief Judge as soon as possible.

The order for familiarization will be based on the team results from the previous WWF World Championships with the last placed team athletes going first, and shall be grouped by event, i.e., slalom familiarization, trick familiarization and jump familiarization (by jump height) will be grouped together. Any athlete whose time has not been paid for at least 30 days before the scheduled start of the event, or who is not ready to ski in accordance with the schedule, will lose their official familiarization time.

SUMMARY TABLE

45 days before 12-07-2025 deadline for publishing familiarisation schedule by Organiser.

30 days before 27-07-2025 deadline for familiarisation payment.

The Chief Judge shall have the discretion to change the start time of team's familiarisation based on extraordinary circumstances.

During the Official Familiarisation period the Chief Judge may allocate any available site familiarisation times but only to skiers who have not already used it or do not have time allocated.

The cost per hour for Official familiarisation is € 300,00 (€ 5,00 per minute)





23. TRAVEL INSURANCE

The IWWF Bye-Law 16.1 states:

It is the responsibility of each Federation when entering competitors for a World Titled Event to ensure that its competitors are adequately insured for accidents, permanent disabilities, death and medical expenses etc.

24. ATHLETE INFORMATION FOR COMMENTATORS

Please request your athletes to log into IWWF's EMS (https://ems.iwwf.sport/) to fill in / update their profiles (accomplishments, sponsors, social media handles, other interesting information in the optional fields, etc.) so the event commentator has information available to communicate to spectators present at the event venue and online via live stream. They should also upload photos for media use. Athletes should contact their respective Federations if they are not active/confirmed EMS users.

25. DOPING CONTROL

In accordance with the IWWF anti-Doping Rules, drugs controls will be conducted during the competition. By entering this competition, all athletes agree to be subject to doping control. A1. IWWF ATHELETE CONSENT FORM

As a member of a National Federation affiliated to the International Waterski & Wakeboard Federation and a participant in an event authorized or recognized by the International Waterski & Wakeboard Federation, I hereby declare as follows:

- 1. I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of the IWWF Anti-Doping Rules (as amended from time to time), the World Anti-Doping Code (the "Code") and the International Standards issued by the World Anti-Doping Agency, as amended from time to time, and published on WADA's website.
- 2. I consent and agree to the creation of my profile in the WADA Doping Control Clearing House ("ADAMS"), as requested under the Code to which IWWF is a Signatory, and/or any other authorized National Anti-Doping Organization's similar system for the sharing of information, and to the entry n my Doping Control, Whereabouts and Therapeutic Use Exemptions related data in such systems.
- 3. I agree that during the Event and for up to ninety (90) days thereafter as may be needed for follow up testing, I will be subject to blood and/or urine testing for any substance or method on the World Anti-Doping Agency ("WADA") Prohibited List.
- 4. I acknowledge the authority of IWWF [and its member National Federations and/or National Anti-Doping Organizations] under the IWWF Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the IWWF Anti- Doping Rules.
- 5. I acknowledge and agree that any dispute arising out of a decision made pursuant to the IWWF Anti-Doping Rules, after exhaustion of the process expressly provided for in the IWWF Anti-Doping Rules, may be appealed exclusively as provided in Article [13] of the IWWF Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
- 6. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
