Located at Borgo San Pietro, Lago del Salto is a hydro-electric basin built in the early years of the last century, able to guarantee a water reserve and an electricity production capable to satisfy the needs of the resident population between Rieti and Rome. Lago del Salto - Borgo San Pietro, has

hosted prestigious national competitions since 1998, the IWWF European Wakeboard Championships in 2014 and 2018, and the IWWF World Wakeboard Championships in 2022.

7.2: IWWF License

Following an agreement by the IWWF World Congress held in 2019, the IWWF Executive Board approved the establishment of an [IWWF License](#) fee from 2021 where athletes wishing to compete in Ranking List / 3 to 6 Star competitions (including IWWF World titled events) in each Sports Division of the IWWF are required to hold an IWWF License. It is requested that Federations ensure that all their athletes hold a valid IWWF License to participate in the 2026 IWWF World Wakeboard Championships.

8. CATEGORIES

8.1: Minimum Number of Riders / Country Representation

There will be a minimum of 3 different countries represented required to open a category. The categories to be opened will be determined after the end of the registration. Once a category is open then the scores and the placement of riders in that category will contribute to team scores and to a title. A rider will only be allowed to enter one category, either the appropriate age-group category or a higher level of difficulty category than his/her own age-group category.

8.2: Date of Birth

A rider's age as of 31st December 2026 will be used to determine age bracket.

8.3: Categories

U14 - 14 and Under (Boys) & (Girls)

14 years old and under - if you are 14 years or under on December 31st in the current year the event is held

U18 - 18 years and Under (Junior Men) & (Junior Women)

18 years and under – if you are 18 years or under on December 31st in the current year the event is held

O30 - 30 Years and Over (Master Men) & (Master Women)

30 years or older on December 31st in the current year the event is held

O40 - 40 Years and Over (Veteran Men) & (Veteran Women)

40 years or older on December 31st in the current year the event is held

O50 - 50 Years and Over / Legends Men) & (Legends Women)

50 years or older on December 31st in the current year the event is held

Open Division (Open Men) & (Open Women)

No age restriction

9. PAYMENTS

Payment of Intent to Enter, Entry and Unofficial Familiarization Fees must ONLY be made by bank transfer.

Remitting parties are responsible for ALL bank charges at both ends. Where bank charges have been deducted, Federations/Riders will be required to make good any shortfall at registration. Please present your Bank Transfer Voucher during registration on site to prove your payment.

10 INTENTION TO ENTER & ENTRIES

Each Federation shall submit an Intention to Enter Form no later than **3rd May 2026** as per IWWF Wakeboard. **Any Federation not meeting this requirement will not be allowed to compete until they pay a fine of €250. For each participant entered on the Intention to Enter form, the Federation must pay a deposit of €50, this payment is non-refundable.** This payment will ensure the number of riders participating is accurate and will enable the planning of the event. If the Federation enters the number of riders as indicated in the Intention to Enter, the payment made will be deducted from the entry fee. If the Federation enters less riders than the number indicated on the Intention to Enter, the €50 paid for each of the riders not attending will be forfeited. The Federation may enter up to 2 additional riders more than originally declared on the Intention to Enter form. If more than 2 additional riders participate, then a fee of €50 per additional rider will be levied on the Federation.

10.1: Team Entry

Team Entry

All riders participating will be considered team members. It is encouraged to have a mixed participation with male and female riders, and riders entered in as many categories as possible. Team scoring will be used for country classification at Titled Championship events.

10.2: Individual Entry

Riders who are not part of a team may compete as individuals. An individual rider's entry must be submitted through his respective Federation using the official entry forms. Deadline to Register Athletes in EMS & Transfer Entry Fees by the 3rd of June to avoid €10 per rider per day fine. Any individual entering must complete registration by attending the Scorers office with his/her passport 39 hours prior to the start of the event. Federations will decide the criteria for an individual rider's entry. There is no restriction to the number of riders who enter International Titled events as individual competitors.

10.3: Fees

The Entry Fee will be €250 per rider (including the €50 deposit). The deadline for payment is 3rd June 2026.

10.4: Registration of participants (athletes) in EMS

Each Federation shall register the athletes on the EMS not later than sixty (60) days before the scheduled start of the first event of the competition, with the names of the members of its team and reserves and the events each will enter. The deadline for entry of athletes on EMS is 3rd, June 2026. Any Federation not meeting this requirement will not be allowed to compete until the Federation pays a fine of €10 per rider per day after the 10-day deadline for each rider not officially entered. Late entries will only be accepted with the mutual consent of the Organizer and Chief Judge.

The registration of the rider participation in EMS must be done by an EMS Federation Administrator as follows:

1. EMS Federation Administrator has to login to EMS
2. Go to the Competitions menu and set the Competition Code <[26IWWF06](#)> and the Country "Italy" in the Search Filters
3. Select the Code <[26IWWF06](#)> competition "2026 IWWF World Wakeboard Championships"
4. Scroll down to the Participations section and click the "New participation" button to register the Athletes
5. Enter the Name of the Athlete in the Search box and click on the loop sign to the right
6. Register the Category in Competition, the Event "and the Entry Type.
7. Click on the blue "+Add" button and the participant will be registered.

Repeat Steps 5 to 7 for any additional participants

Any Federation not meeting this requirement will not be allowed to compete until the Federation pays a fine of €10 per rider per day after this deadline for each rider not officially entered. Late entries will only be accepted with the mutual consent of the Organizer and Chief Judge.

11 OFFICIAL FAMILIARIZATION

The cost of Official Familiarization at the Event Venue will be €50 per rider for a ten-minute slot. Each rider will only be allocated one ten-minute slot. Time slots will be given on a first come first served paid basis, by WakeboardChair@iwwf.sport only. Time slots will only be confirmed when payment is received. The Official Familiarization schedule will be subject to the number of riders and will be posted by the Organizers no later than 5 days before the beginning of the event.

In Italy, power plugs and sockets (outlets) of type C and type I are used. The standard voltage is 220V at a frequency of 50Hz.





A2. IWWF ATHELETE CONSENT FORM

2026 IWWF WORLD WAKEBOAT CHAMPIONSHIPS

As a member of a National Federation affiliated to the International Waterski & Wakeboard Federation and a participant in an event authorized or recognized by the International Waterski & Wakeboard Federation, I hereby declare as follows:

1. I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of the IWWF Anti-Doping Rules (as amended from time to time), the World Anti-Doping Code (the "Code") and the International Standards issued by the World Anti-Doping Agency, as amended from time to time, and published on WADA's website.
2. I consent and agree to the creation of my profile in the WADA Doping Control Clearing House ("ADAMS"), as requested under the Code to which IWWF is a Signatory, and/or any other authorized National Anti-Doping Organization's similar system for the sharing of information, and to the entry in my Doping Control, Whereabouts and Therapeutic Use Exemptions related data in such systems.
3. I agree that during the Event and for up to ninety (90) days thereafter as may be needed for follow up testing, I will be subject to blood and/or urine testing for any substance or method on the World Anti-Doping Agency ("WADA") Prohibited List.
4. I acknowledge the authority of IWWF [and its member National Federations and/or National Anti-Doping Organizations] under the IWWF Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the IWWF Anti-Doping Rules.
5. I acknowledge and agree that any dispute arising out of a decision made pursuant to the IWWF Anti-Doping Rules, after exhaustion of the process expressly provided for in the IWWF Anti-Doping Rules, may be appealed exclusively as provided in Article [13] of the IWWF Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
6. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
